RECEIPIENT SELECTION

The winners of this scholarship will be decided based on the following:

Financial Need determined through legal guardian or parents' tax return from the previous year	35%
Transcripts that show cumulative GPA up until the first semester of 12 th grade (Senior year)	25%
Personal statement emphasizing applicant's community activity performed and honors / awards received during school years	25%
Reference letter describing why the applicant deserves this scholarship	10%
BankCard Services merchant history	5%
